### BOOKING CONDITIONS

1. All bookings are subject to these conditions. No contract exists until the deposit payment and a confirmation invoice has been issued. The Client warrants that he/she is over 18 years old and has the authority to sign the booking form on behalf of the party who shall be bound by the terms of these conditions. Conditions laid down on the booking form shall take precedent over the general conditions below.
2. If, after our confirmation has been issued, you wish to change your booking, we will do our utmost to make the changes, provided that notification is received in writing at our offices from the person who signed the booking form. This must be accompanied by a payment of £25 to cover our administration costs.
3. It is unlikely that we will have to make any changes to the programme, but this may be necessary, and we reserve the right to do this at any time. Most of these changes are minor and we will advise you at the earliest possible date.
4. The Company reserves the right in any circumstances to cancel the programme if we have insufficient numbers of participants and for reasons of force majeure or war, terrorism or if the organisers deem it necessary or change the programme.
5. The Company will not be liable for any losses or additional expenses due to war, threat of war, riots, civil strife, industrial dispute, terrorist activity, natural or nuclear disasters, fire, adverse weather conditions and similar events beyond the Company's control.

### CHANGES & CANCELLATIONS

1. The amount of cancellation charges will be determined from the date on which written notice of cancellation is received in accordance with the following scale:
